DEMOLITION PERMIT APPLICATION

Demolition work shall include:

1. Gas and Electrical services disconnected prior to start of work.
2. Protection of public property by suitable barricades must be provided, throughout the duration of the demolition.
3. Removing of foundations and all debris from the premises. (If a debris container will be needed, arrangements must be made with the City of Greenfield City Hall.)
4. Filling of excavations to grade and clean fill.
5. Terminating underground utilities and capping them a minimum of 12" below grade.
