NOTICE OF PUBLIC HEARINGS

Pursuant to Elections Code section 10010(a), the City of Greenfield intends to hold public hearings at the date and times identified below, at which time the public is invited to provide input regarding the content of draft maps and proposed sequence of election, if applicable, for the transition to by-district elections. The draft maps shall be published at least seven days before consideration at the public hearings and will be available on the City of Greenfield's website on or before February 16, 2022, at the following internet address:

In the event a draft map is revised at or following a public hearing, the revised map shall be published and made available to the public at the above referenced internet address for at least seven days before being adopted.

The City Council for the City of Greenfield will be holding its first post-map public hearing on Wednesday, February 23, 2022, and will be holding its second post-map public hearing on Wednesday, March 16, 2022. Consistent with Assembly Bill (AB) 361, the City Council will hold these meetings virtually only, without in-person attendance by the public and without a physical location for public participation. Further, and consistent with AB 361, the meetings are accessible for public participation through video conferencing and livestreaming.

Whether comments submitted by email are read aloud at the hearing is at the discretion of the City Council. Comments submitted by email that are not received on time will not be accepted. Please be aware that written public comments, including your name, may become public information.
